Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or any other order or direction particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No. 6 and 7 in not taking action by considering the representation dated : 09.07.2026 submitted by the Petitioner to admit his sister namely Ayesha Jabeen D/o Syed Abdul Shukoor into 7th Respondent hospital as arbitrary, illegal and contrary to the provisions of the Mental Health Care Act, 2017.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent No. 6 & 7 to forthwith admit petitioners sister namely Ayesha Jabeen D/o. Syed Abdul Shukoor into the 7th Respondent hospital, pending disposal of WP No. 27039 of 2026, on the file of the High Court.

The petition coming on for hearing. upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI MOHD ASHFAQ Advocate for the Petitioner and GP FOR HOME for the Respondents No. 1. 3. 4. 5 and 6 and GP FOR MEDICAL HEALTH AND FAMILY WELFARE for the Respondents No.2 and 7, the Court made the following.

**ORDER:**

**Learned counsel for the petitioner submitted that in spite of addressing a letter dt.09.07.2026 to refer the petitioner's sister to a mental hospital, the respondents are not taking any action.**

**Learned Assistant Government Pleader for Home, on written instructions, submits that a petition has been filed before the VI Additional Chief Metropolitan Magistrate at Hyderabad for necessary directions in this regard and the Court has required the respondent police to produce the medical records of the petitioner's sister and that when the police contacted the petitioner to produce the medical records of his sister, he has not submitted the said records.**

**Learned counsel for the petitioner submits that the medical record was supplied along with letter dt.09.07.2026, however, he is also willing to supply the record again.**

**The petitioner is therefore directed to submit the medical records of his sister with regard to her mental illness to the police.**
