Petition under Section 389(1) of Cr.P.C/430(1) of BNSS, praying that in the circumstances stated in the grounds filed in support of the CRIMINAL APPEAL, the High Court may be to grant interim bail to the petitioner/accused No.1 he has to attend the funeral ceremony of his brother on 12th day ceremony who is expired on 04/04/2026 vide SC.No.158 of 2016 by the IInd Additional District Judge, Mahabubnagar, At present he is in Central Prison Cherlapally, vide CT.No.5461., pending disposal of CRLA No 908 of 2024, on the file of the High Court.

The appeal coming on for hearing, upon perusing the appeal and the grounds filed in support thereof and upon hearing the arguments of Sri Mettu Govardhan Reddy, Advocate for the Appellants and Sri Syed Yasar Mamoon, Addl. Public Prosecutor for the Respondent, the Court made the following.

ORDER:

Heard Sri Mettu Goverdhan Reddy, learned counsel for the petitioner/Accused No.1 and Sri Syed Yasar Mamoon, learned Additional Public Prosecutor.

This application is filed seeking interim bail to the petitioner/Accused No.1 on the ground that his brother expired on 04.04.2026 and 12th day ceremony is scheduled on 15.04.2026.

In the light of the same, we have directed learned Additional Public Prosecutor to get specific instructions with regard to the same. He has produced written instructions dated 13.04.2026 of Station House Officer, I-Town Police Station, Mahabubnagar, confirming the said fact.

In the light of the same, we are inclined to grant interim bail to the petitioner/Accused No.1 herein for a period of ten (10) days.

This application is allowed accordingly, granting interim bail to the petitioner/Accused No.1 for a period of ten (10) days i.e., from 13.04.2026 to 22.04.2026. The Superintendent, Central Prison, Cherlapally, Medchal-Malkajgiri District, is directed to release the petitioner/Accused No.1 today i.e., on 13.04.2026 at 5.00 P.M. He shall report before Superintendent, Central Prison, Cherlapally, Medchal-Malkajgiri District, on 23.04.2026 by 5.P.M after availing said period. He shall not indulge in any criminal activities during the said period.
