**ORDER:**

Heard Ms.B.Rachna Reddy, learned Senior Counsel appearing for Mr.Mohd.Baseer Riyaz, learned counsel for the petitioner and perused the record.

2. The instant is the Civil Revision Petition which has been filed aggrieved by the order, dated 27.06.2025, passed in I.A.No.2267 of 2025 in O.S.(SR) No.11174 of 2025 on the file of the Chief Judge,City Civil Court, Hyderabad.

3. *Vide* the impugned order, the trial Court has rejected the application filed under Section 148 of the Civil Procedure Code, 1908 (for short "the C.P.C.") seeking for condonation of delay in representing the case file.



4. The petitioner herein is the plaintiff in the main suit before the trial Court and she has filed suit for damages on account of defamation. The petitioner and the respondent both are husband and wife and because of strained relations, disputes arose between two and certain cases are pending before the Family Court. In between, because of conduct of the respondents which, according to the petitioner amounts to defamation and a suit for damages was filed by the petitioner. However, it was returned on 19.06.2023 by the office of Civil Court on the ground of there being deficit Court fee and it was represented again on 28.06.2023. However, for the same default, it was returned. Thereafter, fresh application was filed only on 25.04.2025 along with application under Section 149 of C.P.C. seeking for permission of the Court to deposit the Court fees after the suit stands decided. There was delay of 660 days in resubmitting the bundle. The ground for delay was for the reason of ill-health of the petitioner who was suffering from severe lower back pain and was in also hospitalized on more than couple of occasions. Moreover, the petitioner was also at the initial stage of the suit was appearing in person and at the stage



when application under Section 149 C.P.C. was filed, she engaged an advocate to defend her case. The explanation provided by the petitioner was not found to be satisfactory by the trial Court and disallowed the same. As a consequence, the suit stands dismissed.

5. Learned Senior counsel for the petitioner submits that in the factual backdrop of the cause under which the suit was filed and ill-health of the petitioner that occur subsequently should not come in the way of suit itself being decided against the petitioner and was being rendered remediless for the relief she has sought for. The trial Court could have condoned the delay even on imposing of some minimal costs, more particularly, when the petitioner had filed petitions under Section 148 and 149 of C.P.C.

6. Learned Senior Counsel appearing for the petitioner submits that she has instructions where the petitioner, who is the plaintiff is even now ready to deposit the entire Court fees, if this Court gives liberty to her.

7. Considering the entire factual matrix of the case, and also taking note of the nature of the dispute and claim raised by the petitioner, this Court is of the considered opinion ~~that~~ if the suit is



not restored, the petitioner would be firstly denied of the remedy available for the so-called defamation that she has faced; secondly, the petitioner would not be in a position to pursue the claim any further before any other forum as it may either hit by principles of *res judicata* or the aspect of limitation may come in her way. Thus prayed for setting aside of impugned order and permit the petitioner to deposit the Court fee immediately and thereafter proceed further with the suit to be decided on its own merits.

8. Having considered the contentions of learned Senior Counsel for the petitioner, this Court is of the considered opinion that the impugned order deserves to be set aside at this juncture.

9. On the submissions made by learned Senior Counsel for the petitioner that the petitioner is ready to deposit the entire Court fee, now this Court allows the applications viz., I.A.No.2267 of 2025 and I.A.(SR) No.11175 of 2025 filed under Section 148 and 149 of C.P.C. respectively permitting her to deposit entire deficit Court fees within a period of two weeks from the date of receipt of a copy of this order. In the event, if the said Court fees is deposited, let





the suit be registered and be proceeded on its own merits and decided as early as possible.

10. Accordingly, the Civil Revision Petition stands allowed. The impugned order dated 27.06.2025 is set aside. There shall be no order as to costs.

Consequently, miscellaneous petitions pending, if any, shall stand closed.

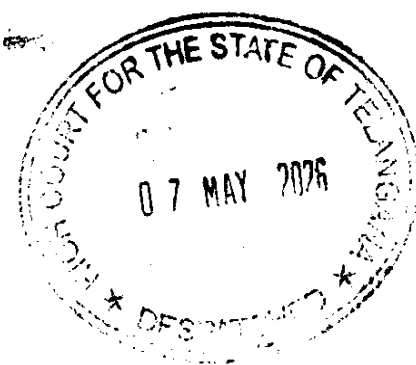
