WHEREAS the Petitioner above named through its Advocate M/S GIRIJA SHANKER SHARMA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to: issue a writ, Order or direction more particularly one in the nature of writ of Mandamus,

i. Declaring the impugned Letter No. SE/OP/ YDD/ SAO/J/40-NT- I/ SA/D.No.244/ 2025, dated 27.06.2025 and subsequent Letter Page 1 of 2 No.SE/ OP/ YDD/ SAO/JAO-HT-II/ SA-1/ D.No.434/ 2025, dated 29.08.2025 issued by the Respondents, are illegal, arbitrary, null and void ab initio, ultra vires, without jurisdiction, and violative of Articles 14 and 19(1)(g) of the Constitution of India, as well as contrary to the provisions of the Electricity Act, 2003.

ii. Declare that the Petitioner is not liable to pay any alleged arrears or surcharge of the alleged HT Service Connection No. YDD089 (Old HT Sc. No.

NLGO89) of M/ s. Universal Ceramics Ltd., and that such liabilities cannot be fastened upon the Petitioner, who holds a fresh, independent LT Service Connection No. 5101401192.

iii. Direct the Respondents to immediately restore the Petitioner's LT Service Connection No. 5101401192, and restrain the Respondents, their officials, agents, or any person acting under their authority, from disconnecting, suspending, obstructing, or interfering with the Petitioner's electricity supply in any manner.

iv. Further restrain the Respondents, their officials, agents, or any person acting under their authority, from issuing any letter/s, notice/s, making demand/s, or taking any coercive action against the Petitioner in respect of LT Service Connection No. 5101401192, under the guise of alleged arrears or any similar claims related to the alleged HT Service Connection No. YDD089 (Old HT Sc. No. NLGO89) of M/ s. Universal Ceramics Ltd.,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/S GIRIJA SHANKER SHARMA Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
