WHEREAS the Petitioner above named through her Advocate Sri V VENKATA MAYUR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order/s more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent Nos. 2 to 4 in not releasing part of the land admeasuring 101 Sq Yds forming part of plot No. 78 in Survey Nos. 29, 30, 31, 36, 37, 67 and 68/B of Nagole Village in pursuance of survey report dt., 26/02/2022 in File No. B/245/2022, which is included in the open space in the layout No. 102234/27/10/2016/HO/768 dated 14/09/2019, as being illegal arbitrary and violative of Articles 21 and 300-A of Constitution of India and consequently direct the respondent Nos. 2 and 4 to release the land admeasuring 101 Sq Yds forming part of plot No. 78 in Survey Nos. 29, 30, 31, 36, 37, 67 and 68/B of Nagole Village which is included in the open space in the layout No. 102234/27/10/2016/HO/768 dated 14.09.2019

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri V VENKATA MAYUR, Advocate for the Petitioner, Mr.M.Durga Prasad, learned Standing Counsel takes notice on behalf of respondent Nos.2 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
