Turkayamjal village, Ragannaguda Grampanchayath, Hayathnagar Revenue Mandal, R.R. District, on the instigation of Respondent Nos.4 to 7 which is illegal, arbitrary against to the principles of natural justice and consequently direct the Respondent Nos.2 and 3 not to interfere in the petitioner s house vide H.Nos.6-11/P-85 and 6-11/P-86 constructed on Plot bearing Nos.85 and 86 admeasuring 200 sq. yards each, in total admeasuring 400 sq. yards and H.No. 6-11/P-33 and 6-11/P-92 constructed on Plot bearing Nos.33 and 92 admeasuring 200 sq. yards each, in total admeasuring 400 sq. yards in Survey Nos.510/A, AA, E,511/A,AA,E, situated at Mannemutyalakunta, Hamlet of Turkayamjal village, Ragannaguda Grampanchayath, Hayathnagar Revenue Mandal, Ranga Reddy District in view of the CMA No.1 of 2023 on the file of I Addl. District Judge, R.R. District which is filed against I.A.No.444/2020 in O.S.No.653/2020 on the file of Senior Civil Judge, R.R.District and report of Tahsildar, Abdullapurmet in Lr.No.C/1295/2022, dt.25.10.2024,
