WHEREAS the Petitioner above named through his Advocate Sri Shakapuram Ramesh presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action Respondent No.4 in withholding the petitioner original education certificates, due to outstanding tuition fee, as illegal, arbitrary and unconstitutional and violation of principles of natural and violation of Article 14,19 and 21 of Constitution of India and against regulations mentioned under rule 2(F)(vi) and Rule 4(C) issued by U.G.C. notification vide file No. 14-4/2012(CPP-1) in October, 2018 and consequently direct the 4th respondent to realise all the original education certificates including SSC Memo, SSC Bonafide Certificate, Intermediate Memo, Intermediate Bonafide Certificate, Caste Certificate, BPT Marks Memos, BPT Original Degree Certificate, BPT Bonafide Certificate, BPT Transcript/Memo Certificate, Migration Certificate and Internship Certificate.
