ORDER:

The learned Additional Public Prosecutor has filed his 4-line instructions in the matter.

The instructions are given by the Circle-Inspector of Police, Rebbena Circle, Kumrambheem Asifabad District. Instructions are bring that the petitioner's family is in financial crises.

Considering the submissions made for grant of interim bail, and the pleadings on record, I.A.No.2 of 2025 is allowed by granting interim bail to the appellant No.3/A3 from tomorrow i.e., 30.04.2025 till 09.06.2025 subject to furnishing a bond of Rs.15,000/- (Rupees fifteen thousand only) with 2 sureties of like amount each, to the satisfaction

of the Superintendent, Central Prison, Cherlapally, Medchal-Malkajgiri District.

The petitioner shall report to the concerned Station House Officer every alternate day till 09.06.2025 and the petitioner shall also make himself available as and when required.

The petitioner shall surrender before the Superintendent, Central Prison, Cherlapalli, Medchal-Malkajgiri District by 05:00 PM on 09.06.2025.
