Petition under Section 430(1) of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the Crl.A., the High Court may be pleased to release the Petitioner/accused No.7 on bail for a period of three months in Criminal Appeal No.961 of 2024 pending disposal of CRLA No.961 of 2024, on the file of the High Court.

The Court made the following

ORDER

The petitioner/accused No.7 (A7) seeks interim bail. The present I.A. has been filed by the mother of the accused person.

After hearing learned counsel appearing for the petitioner/A7 and the learned Additional Public Prosecutor and considering the reasons stated in the affidavit, we are of the view that the petitioner/A7 may be granted interim bail from tomorrow i.e., 30.07.2025 till 15.09.2025.

I.A.No.4 of 2025 is accordingly allowed by granting interim bail to the petitioner/A7 from 30.07.2025 to 15.09.2025 subject to furnishing a bond of Rs.15,000/- (Rupees Fifteen Thousand only) with two sureties of like amount each, to the satisfaction of the Jail Superintendent, Central Prison, Cherlapalli, Medchal- Malkajgiri District.

The petitioner/A7 shall report to the concerned Station House Officer on every alternate day till 15.09.2025 and the petitioner/A7 shall also make himself available as and when he is required. The petitioner/A7 shall surrender before the Jail Superintendent, Central Prison, Cherlapalli, Medchal-Malkajgiri District by 5:00 P.M. on 15.09.2025.

Since the learned Additional Public Prosecutor has raised an apprehension that the petitioner/A7 may be at risk from the relatives of the deceased, we make it clear that the petitioner/A7 shall not make any effort of contacting the family members of the deceased person.
