	16.03.2026	<u>KL, J & BRMR, J</u> <u>I.A.No.1 of 2026</u> This application is filed to relax the condition No.III imposed <i>vide</i> order dated 06.10.2025 in I.A.No.1 of 2024 in CrI.A.No.961 of 2024. <i>Vide</i> the aforesaid order, we have granted bail to the petitioners/accused Nos.3, 8, 9 and 10 by imposing certain conditions including the condition that they shall report before Rebbena Police Station, Kumarambheem Asifabad District, once in a week i.e., every Sunday between 10.00 A.M. and 05.00 P.M. pending disposal of the appeal. Petitioners seeking relaxation of the said condition contending that petitioner No.1/accused No.3 is a Village elder and he is suffering with health issues, petitioner No.2/accused No.8 is working as male nursing staff in Sri Surya Hospital, Godavarikhani, petitioner No.3/accused No.9 is a Python Developer and he is doing internship with Clinch Fusion Bridge and petitioner No.4/accused No.10 is working as Centre Associate, Dr.Reddy's Foundation, Hyderabad. They have also filed appointment orders, etc. Therefore, we have directed the learned Additional Public Prosecutor to get specific instructions on the same. He has confirmed the said facts. On instructions, he would further submit that the petitioners have complied with the aforesaid condition <i>vide</i> the aforesaid order dated	

		06.10.2025. In the light of the same, we are inclined to relax the aforesaid condition No.III imposed <i>vide</i> order dated 06.10.2025 in I.A.No.1 of 2024 in CrI.A.No.961 of 2024. The other conditions remaining unaltered. Petitioners are directed not to involve in any criminal activities and not to threaten the witnesses, otherwise liberty is granted to the police to seek cancellation of bail granted to the petitioners herein. <u>I.A.No.2 of 2026</u> This application is filed to relax the condition No.II imposed <i>vide</i> order dated 07.11.2025 in I.A.No.6 of 2025 in CrI.A.No.961 of 2024. <i>Vide</i> the aforesaid order, we have granted bail to the petitioner/accused No.7 by imposing certain conditions including the condition that he shall report before Rebbena Police Station, Kumarambheem Asifabad District, once in a week i.e., every Sunday between 10.00 A.M. and 05.00 P.M. pending disposal of the appeal. Petitioner seeking relaxation of the said condition contending that he is trying for employment and residing in Miyapur, Hyderabad. It is causing inconvenience to attend the Rebbena Police Station, which is about 330 K.Ms. Whereas, learned Additional Public Prosecutor, on instructions, would submit that the petitioner is residing in Miyapur, Hyderabad, and he has produced the copy of rental agreement. Considering the fact that the petitioner is trying for employment, we are inclined to relax the aforesaid condition No.II imposed <i>vide</i> order dated 07.11.2025 in

I.A.No.6 of 2025 in Crl.A.No.961 of 2024. Petitioner shall report before Rebbena Police Station, Kumarambheem Asifabad District, once in a month i.e., every first Sunday between 10.00 A.M. and 05.00 P.M. pending disposal of the appeal. Petitioner is directed not to involve in any criminal activities and not to threaten the witnesses, otherwise liberty is granted to the police to seek cancellation of bail granted to the petitioner herein.
