Rama Chander Reddy, the learned Additional Public Prosecutor appearing for the respondent - State. <u>I.A.NO.1 OF 2025</u> <u>IN</u> <u>CRL.A.NO.961 OF 2025</u> The petitioner/appellant No.5/accused No.10 seeks interim bail on the ground that the B.Com (Computers) examinations at Mahatma Gandhi University, Nalgonda, are scheduled from 11.04.2025 to 13.05.2025. The I.A. includes a copy of the examination schedule and evidence of the petitioner having made payment of the examination fees for both Semesters. The learned Additional Public Prosecutor appearing for the respondent-State has provided written instructions confirming that the examinations are being held on the dates mentioned above and that the petitioner is a student of Jagruthi Degree & P.G. College, Bhongir, Yadadri-Bhuvanagiri District. Considering the above material on record, we deem it fit to grant interim bail to the petitioner for the purpose of writing the final examinations for the 5th and 6th Semesters. The petitioner's sentence of conviction is	

		suspended. I.A.No.1 of 2025 is accordingly allowed by granting interim bail to the petitioner/appellant No.5/accused No.10 from 09.04.2025 till 19.05.2025, subject to furnishing a bond of Rs.15,000/- (Rupees fifteen thousand only) with two sureties of like amount each, to the satisfaction of the Jail Superintendent, Cherlapally Jail, Medchal-Malkajgiri District. The petitioner shall report to the concerned Station House Officer every alternate day till 19.05.2025 and shall also make himself available as and when required. The petitioner shall surrender before the Jail Superintendent, Cherlapally Jail, Medchal-Malkajgiri District, by 5:00 P.M. on 19.05.2025. It is made clear that the petitioner shall not leave Bhongiri Town, Yadadri-Bhuvanagiri District, during the period of interim bail. <u>CRL.A.NOs.961, 971 AND 1034 OF 2024</u> List these Appeals on 16.06.2025.
