Petitioner-accused No.1 has strong case in succeeding the appeal. The grounds raised in the appeal may be read as part and parcel of the petition.</p> <p>Petitioner-accused No.1 is tried for the offence under Section 8 (c) read with 20 (b) of the NDPS Act, 1985 in SC (NDPS) No.217 of 2022. After full-fledged trial, the learned I Additional Sessions Judge at Bhadradri Kothagudem has convicted the petitioner-accused No.1 <i>vide</i> judgment dated 03.08.2026 and sentenced him to undergo rigorous imprisonment for a period of five years and shall pay a fine of Rs.25,000/- each.
