	15.12.2025	<u>KL, J & VRKR, J</u> <u>I.A.No.2 of 2025</u> <u>In</u> <u>CrI.A.No.1034 of 2024</u> Heard learned counsel for the petitioner/accused No.6 and Dr.S.Prashanth, learned Assistant Public Prosecutor. This is the second bail application filed by the petitioner/Accused No.6. Vide order dated 06.10.2025, we granted bail to accused Nos.8 and 9 and dismissed the bail application filed by accused Nos.6 and 7. Thereafter, accused No.7 filed I.A. No.6 of 2025 in Criminal Petition No.961 of 2024 seeking bail, contending that he was also standing on the very same footing as accused Nos.8 and 9. On consideration of the said contention, vide order dated 07.11.2025, we granted bail to accused No.7. Thus, this Court has granted bail to accused Nos.7, 8, and 9. We are of the opinion that accused No.6 is also standing on the very same footing as accused Nos.7 to 9. This fact was missed in our earlier order dated 06.10.2025. In light of the same, on the ground of parity, the petitioner herein/accused No.6 is also entitled to bail. Accordingly, this application is allowed. The sentence of imprisonment imposed on the petitioner/accused No.6, <i>vide</i>	

	impugned Judgment dated 16.10.2024 in S.C.No.350 of 2021 on the file of the learned Principal Sessions Judge at Asifabad, alone is suspended pending disposal of the Appeal, and the petitioner/accused No.6, namely, Jarupula Harish, S/o. Tikya Nayak, is released on bail on the following conditions:- i) He shall execute a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) with two (02) sureties for a like sum each to the satisfaction of the learned Principal Sessions Judge at Asifabad. ii) He shall report before Rebbena Police Station, Kumaram Bheem - Asifabad District, once in a week i.e., every Sunday between 10.00 A.M. and 5.00 P.M., pending disposal of the appeal. iii) He shall not indulge in any criminal acts during bail period. iv) In view of the seriousness of allegations and both the families of the deceased and the accused hail from the same village, liberty is granted to the Police, Rebbena Police Station, to seek cancellation of present bail in the event of involvement of the petitioner herein in any criminal activities and any act which disturbs peace and tranquility in the Village while he is on bail. _____ KL, J _____ VRKR, J <u>Crl.A.Nos.1034 and 971 of 2024</u> List on 04.03.2026.
