Petition under Section 430 R/w Section 483 of BNSS, praying that in the circumstances stated in support of the petition, the High Court may be pleased to enlarge the petitioner on bail pending disposal of Criminal Appeal No.971 of 2024 for a period of five to six months as a temporary arrangement to take care of his wife;

The petition coming on for hearing, upon perusing the Petition filed in support thereof and upon hearing the arguments of Sri Ennamsetty Akhil, Advocate Representing M/s Jurislit Law LLP Advocate for the petitioner and Additional Public Prosecutor for the respondent, the Court made the following

ORDER:

We have considered the written instructions handed up by the learned Additional Public Prosecutor which confirms that the appellant's wife is at an advanced stage of pregnancy. The documents annexed to I.A.No.1 of 2025 show that the expected date of delivery is on 31.05.2025.

Learned counsel appearing for the petitioner prays for interim bail 15 days prior to the expected date of delivery.

I.A.No.1 of 2025 is accordingly allowed and disposed of by granting interim bail to the petitioner/A.15 from 16.05.2025 till 14.07.2025 subject to furnishing a bond of Rs.15,000/- (Rupees fifteen thousand only) with 2 sureties of like amount each, to the satisfaction

of the Superintendent, Central Prison, Cherlapalli, Medchal-Malkajgiri District.

The petitioner shall report to the concerned Station House Officer every alternate day till 14.07.2025 and the petitioner shall also make himself available as and when the petitioner is required. The petitioner shall surrender before the Superintendent, Central Prison, Cherlapalli, Medchal-Malkajgiri District by 05:00 PM on 14.07.2025.
