Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to vacate the interim order dated: 22.11.2024 passed in IA No.1 of 2024 in WP No.32362 of 2024 and dismiss the Writ Petition in the interests of Justice, pending disposal of WP No. 32362 of 2024, on the file of the High Court.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the operation of the impugned seniority list of Deputy Registrars of Cooperative Societies issued in proceedings in Rc. No. 639/2021/SG. 1 dated 26.10.2024 by the 2nd respondent, pending disposal of WP No. 32362 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated. 17.12.2024, 20.12.2024, 24.12.2024, 30.12.2024 and 02.01.2025 made herein and upon hearing the arguments of the above mentioned counsels.

**The Court made the following
ORDER**

This interlocutory application is filed by respondent Nos.4 and 6 in the main Writ Petition, seeking to vacate the interim order dated 22.11.2024 passed by this Court in W.P.No.32362 of 2024, wherein, the respondents were directed not to effect any promotions in pursuance of the seniority list dated 26.10.2024 till 20.12.2024, and the same was extended periodically.

Learned counsel for the applicants herein submits that as on the date of interim order of this Court i.e., 22.11.2024, the case of applicant No.2 herein (respondent No.6 in the main Writ Petition) for notional promotion to the post of Joint Registrar was already pending consideration before the official respondents, and the Writ Petitioners had already been notionally promoted to the post of Joint Registrar. However, on account of the interim order of this Court dated 22.11.2024, the official respondents are not considering the case of applicant No.2 herein for notional promotion to the post of Joint Registrar. Therefore, the learned counsel prays this Court to vacate the interim order dated 22.11.2024 and seeks a direction to the official respondents to consider the case of applicant No.2 for notional promotion to the post of Joint Registrar.

Learned counsel appearing for the Writ Petitioners expressed no objection in modification of the interim order in respect of applicant No.2 i.e., respondent No.6 in the main Writ Petition.

In view of the above, the official respondents (respondent Nos.1 to 3 in the main Writ Petition) are directed to consider the case of applicant No.2 i.e., respondent No.6 in the main Writ Petition, for notional promotion to the post of Joint Registrar, without reference to the interim order of this Court dated 22.11.2024.

Accordingly, this interlocutory application is ordered and the interim order dated 22.11.2024 is modified to the above extent.
