WHEREAS the Petitioner above named through their Advocate SRI DHANA LAKSHMI TALLAPALEM presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more in the nature of Writ of Mandamus declaring the inaction of the Respondents more specifically Respondent No.2 to 4, in initiating action against the illegal and unauthorised construction undertaken by Respondent.No.5 and 6 in the scheduled property in H.No.5-5-340, Uroob Street, Prakasham Baazar, Nalgonda District in an unauthorised manner as , as wholly illegal, arbitrary and contrary to provisions of Article 14 and 21 of Constitution of India and consequently direct the Respondent.No.2 to 4 to take immediate action against the illegal construction and consequently a direction to demolish the deviations constructed in contrary to the

sanctioned plan and to remove the highhanded construction made in the common lane on the Petitioner as illegal;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri DHANA LAKSHMI TALLAPALEM Advocate for the Petitioner, directed issue of notice to the Respondent Nos. 5 and 6, herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct Respondents 2 to 4 to forthwith stop the construction undertaken on warfoot basis and demolish the deviation construction made in the common lane of the petitioners, as otherwise the Petitioners will suffer grave and irreparable loss which cannot be compensated monetarily or otherwise., pending disposal of WP No. 32545 of 2025, on the file of the High Court.

**The Court made the following:
ORDER**

Learned Standing Counsel for respondent Nos.2 to 4 submitted that on complaint of the petitioners, action was initiated against respondent Nos.5 and 6 regarding unauthorized construction. Speaking order was passed on 29.08.2024.

There shall be interim direction to respondent No.2 to implement the speaking order dated 29.08.2024 within a period of four (04) weeks from the date of receipt of a copy of this order, by following due process of law.

Issue notice to respondent Nos 5 and 6.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.5 and 6 and file proof of service by the next date of hearing.
