ORDER:

The present Civil Revision Petition is filed aggrieved by the order dated 10.09.2025 passed in E.A.No.39 of 2024 in E.P.No.206 of 2015 in O.S.No.112 of 2010 on the file of the Principal Junior Civil Judge-cum-Judicial Magistrate of First Class at Miryalaguda.

2. When the matter is taken up for hearing, learned counsel appearing for the petitioners submits that the trial Court passed the impugned order in favour of a dead person.

3. Learned counsel appearing for the respondents submits that the respondents have filed L.R. petition and the same was allowed by the trial Court. Even though, the trial Court passed the impugned order in favour of a dead person without making amendment in the cause title.

4. In the above circumstances, since the LR petition is already ordered, the trial Court is directed to amend the cause title by impleading the LRs of the deceased plaintiff and issue order accordingly.

5. Accordingly, the Civil Revision Petition is disposed of.
No order as to costs.

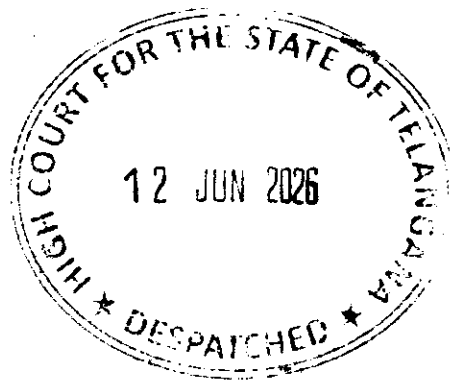
