Mr. P. Venugopal, learned Senior Counsel represents Mr. Mohammed

2. The writ petition was preferred with the following prayer:

“For the reasons stated in the accompanying affidavit, it is hereby prayed that this Hon’ble Court may be pleased to issue an order, direction or writ, more particularly one in the nature of writ of Mandamus, declaring the inaction of the respondents 1 to 4 in not investigating into the complaints/petitions, dated 27.06.2005, 09.09.2005, 20.09.2005 and 30.09.2005 and a complaint made in January 2006, against the 5th r herein, as arbitrary, illegal and violative of Article 14 and 21 of the Constitution of India and consequently direct the respondents 1 to 4 to register a criminal case against 5th and 6th respondents and order an independent investigation to be conducted by appropriate and competent police authority, who is not below the rank of Superintendent of Police and further direct the respondents 1 to 4 to take appropriate action against respondents 5 and 6 so as to punish them in accordance with law and to pass such other order or orders as are deemed fit and proper in the circumstances of the case.”



3. The learned writ Court by the impugned order dated 04.09.2024 dismissed the writ petition as without merit. Being aggrieved, this appeal has been preferred under Clause 15 of the Letters Patent Appeal.

4. Since the nature of the relief prayed for by the appellant/writ petitioner under Article 226 of the Constitution of India is for investigation into the complaints/petitions filed by him and consequently direct the official respondents to register a criminal case against respondent Nos.5 and 6, the proceedings would not qualify as a civil proceedings against which intra-court appeal under Clause 15 of the Letters Patent Appeal would apply. Therefore, following the ratio rendered by the Hon'ble Apex Court in **Ram Kishan Fauji v. State of Haryana**¹ relied upon by the learned Senior Counsel for respondent No.5, the present appeal is held to be not maintainable.

5. Accordingly, the writ appeal is dismissed as not maintainable. There shall be no order as to costs.

Miscellaneous applications, if any pending, shall stand closed.

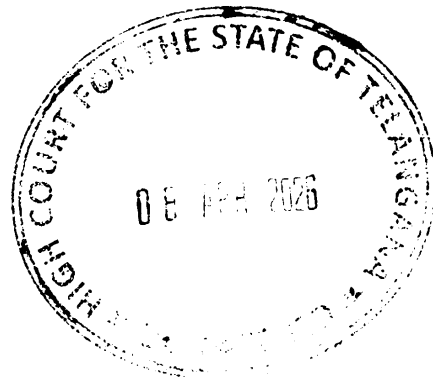
