COMMON ORDER:

3. Heard learned Counsel for the applicants, Sri G. Kalyan Chakravarthy, learned Standing Counsel appearing for the Official Liquidator, and perused the record.

4. The applicants in all these applications contend that they were the workmen of the Company-in-Liquidation; that by virtue

of their employment with the Company-in-Liquidation, they have been allotted with quarters for their stay and even after the company went into liquidation, they are continuing in possession of the said quarters.

5. It is further contended that this Court by order, dated 01.05.2009, in C.A. No.2331 of 2004 in RCC No.2 of 2000 had allotted 48 square yards each to 418 workmen of the company and that the applicants are also similarly situated.

6. It is further contended that this Court by order in C.A. No.2331 of 2004, directed all the workmen, who were allotted quarters to be moved from their respective quarters to a layout that has been laid in the land of the Company in Liquidation and allotted 48 sq. yards to each of the 418 workers, who were in possession of quarters allotted to them by virtue of their employment with the company in liquidation.

7. The applicants in the present applications contend that they were also in employment with the company in liquidation and were also allotted quarters in respect of numbers for their stay during their employment.

8. Applicants further contend that, though this Court by order in C.A. No.2331 of 2004 had allotted 48 sq. yards to each

of the 418 workmen, who are applicants therein, in a specially earmarked layout, since the present applicants have not been considered for allotment of land in the said layout, the applicants continued to occupy their respective quarters, along with the land appurtenant thereto, and are living therein by eking out their livelihood by taking up some other menial jobs; and that if the applicants are thrown out from their quarters, they would have no place to live in.

9. Learned Standing Counsel appearing for the Company in Liquidation has from time to time filed Common Report, dated 22.04.2022 and 19.09.2022, and also Supplementary Report, dated 23.09.2022. By the said reports as filed into this Court, learned Standing Counsel appearing for the Official Liquidator submits that the applicants in all these applications are workers of the Company in Liquidation and insofar as the applicants mentioned at serial Nos.2 to 13 in the report dated 19.09.2022, they have also lodged claims before the Official Liquidator claiming certain amounts as due and payable by the Company in Liquidation, which have been duly adjudicated by the Official Liquidator as payable to them. However, the said amount has not been paid to the applicants mentioned at serial Nos.2 to 13 and the said amount lying with the Official Liquidator has been

transferred to the Registrar of Companies as per Section 555(1) of the Companies Act, 1956 during the period 2017-18. However, by the said Reports, it is further stated that no claims have been made by the applicants in C.A. No.275 of 2009 and C.A. No.210 of 2010.

10. The above said Common Report and Supplementary Report of the Official Liquidator is taken on record.

11. Since it is not in dispute that the applicants in all these applications are the workers working with the Company in Liquidation, prior to the same having gone into liquidation. It is also not in dispute that they have been in occupation of the quarters which have been constructed in the property of the Company in Liquidation and are continuing to be in possession thereof, even during the liquidation process. This Court, in order to put all the workers, who were allotted quarters by the Company during their employment, by bringing them together to be located at one place, so that the vacant land would be available for being disposed of to meet the liabilities of the Company in Liquidation had appointed a Consultant to prepare a layout, wherein 418 workers of the company have been allotted 48 square yards each for moving thereinto.

12. The applicants herein, who were also allotted quarters, are not part of the said allotment and they continued to be in possession of their respective quarters which are outside the purview of the Company Application No.2331 of 2004.

13. Learned Standing Counsel appearing on behalf of the Official Liquidator, by the Common Report and the Supplementary Report, submits that each one of the present applicants are in possession of the land of the Company in excess of the 48 square yards (as shown in the Annexure appended to the Common Report) that has been allotted to them and thus even if they are also to be considered as eligible for being conferred with similar benefit, the excess land is required to be repossessed or that the occupants of the excess land should be directed to make payment for the excess land held by them.

14. Learned Counsel appearing for the applicants in all these applications have agreed to make payment for the excess land in their possession over and above, 48 square yards as has been allotted to the 418 workmen at the rates as may be directed by this Court.

15. The consultant appointed by this Court viz., M/s. Vajra Infracon India Pvt. Ltd., had indicated that the registered value as per the company records of the area where the assets of the Company in Liquidation situated is about Rs.5,000/- per sq. yards.

16. Taking the above said rate indicated by the consultant appointed by this Court for preparation of the layout as the basis, this Court had indicated to the applicants in all these applications that they would be required to pay for the excess land beyond the 48 square yards in their possession by fixing the rates as under:

17. By the Common Report of the Assistant Official Liquidator as filed into this Court, each of the petitioners herein is shown in occupation of excess land as mentioned in the Common Report, dated 22.04.2022.

18. Thus, the amount payable by the applicants in all these Company Applications as agreed before this Court, except in C.A. Nos.208 and 210 of 2010, for the land in their occupation in excess of 48 sq. yards, as per the Report of the Official Liquidator, is as follows:

19. Inasmuch as the excess land in possession of each of these applicants is appurtenant to their quarters, no useful purpose would be served by re-possessing the same by the

Official Liquidator and all such land re-possessed would not become contiguous to one another, but constitute one piece that can be liquidated. In such view of the possession of the land, instead of the Official Liquidator taking possession of the land in excess of 48 square yards which would yield no result even if put to sale by the Official Liquidator, this Court is of the view that the land should be offered for being barred by the applicants herein at the rates by making payment therefor as mentioned hereinabove by each of the applicants in their respective company applications.

20. Upon the applicants making the said payment as mentioned hereinabove to the Official Liquidator, the Official Liquidator shall execute necessary conveyance in favour of each of the applicants including the excess land along with 48 square yards, to which they are entitled to as like the other applicants, who are similarly placed, by virtue of the order of this Court in C.A. No.2331 of 2004.

21. In so far as the applicants in C.A. No.208 and 210 of 2010 are concerned, since it is claimed that the applicants therein also were workers working with the Company in Liquidation, they would also be entitled for a similar benefit. However, since

the property which is in their possession has not been surveyed and the excess area is not determined, the Official Liquidator is permitted to get the property surveyed to determine the excess land in their possession beyond 48 square yards. Upon such conduct of survey by the Official Liquidator and determination of the excess land in possession of the applicants in C.A. No.208 and 210 of 2010, the said applicants would also be entitled for the relief as granted herein above. Upon such determination, the applicants shall make payments as determined by the Official Liquidator for excess land in accordance with para 16 of this order, and upon making payment thereof, the Official Liquidator shall also execute conveyance/sale deed in favour of the applicants in C.A. No.208 and 210 of 2010.

22. The amount for the excess land as determined by this Court at the rates mentioned hereinabove is by taking note of the claim adjudicated by the Official Liquidator and is to be treated towards full and final settlement in all respects. However, it is made clear that the applicants herein would be required to pay the necessary stamp duty on the entire extent of the respective property being conveyed by the registering authority.

23. Having regard to the long pendency of the issue, this Court is of the view that the parties should be directed to give a closure to this matter by the end of November, 2022 in all respects.

24. It is also made clear that the indulgence shown by this Court in the present applications is having regard to the peculiar facts and circumstances of this case and also taking note of the fact that the applicants herein have lodged their claims with the Official Liquidator in one form or the other, and that, since no further claims are lodged with the Official Liquidator as indicated in the Common Report, the benefit of this order is in *personam* and cannot be treated as a precedent.

25. Subject to the above, all the Company Applications are ordered.
