The Interim stay granted earlier shall stand extended till 05.03.2026.

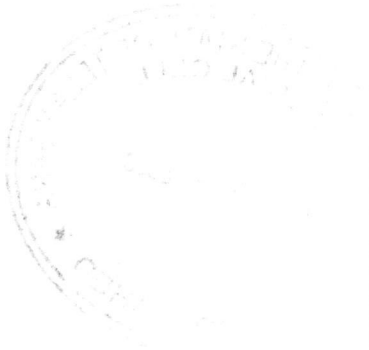
