Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order or Direction in the nature of Writ of Mandamus declaring the action of the Respondent No. 2 in issuing proceedings Rc. No. Zones/2785456/2024, Dated 5/12/2024 posting the petitioner VI - Zone TGSWRS/JC, Shiva reddy pet, Ranga Reddy District when he proceeded on leave from 12/06/2024 on Medical Grounds, issuing posting orders instead of 3 Respondent institution I st Zone placing him VIth Zone which is 480 Kms away from present place of posting that too the petitioner proceeded on Medical Grounds and permitted to Join in duty 480 Km away in VIth Zone is illegal, arbitrary and violation of Principles of Natural Justice and also violation of Fundamental Rights and also violation of G.O.Ms. 317, Dated 6/12/2021 whereas without issuing Re-alignment of Local Cadre proceedings directly placing him to VIth Zone is illegal and arbitrary consequently direct the 2 Respondent to permit the petitioner to Join in the 3rd Respondent institution and continue his services as Librarian in the 3rd Respondent Institution:

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the operation of the 2nd Respondent Proceedings Rc. No. Zones/2785456/2024, Dated 5/12/2024 consequently direct the 2 Respondent to continue the services of the petitioner as a Librarian in the 3rd Respondent institution i.e. TGSWRS/JC, Eturunagaram, Mulugu District which comes under 1st Zone, pending disposal of WP 34896 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri. BUYANI PRIYANKA Advocate for the Petitioner. GP FOR SERVICES-III for the Respondents, the Court made the following.

ORDER:

Notice before Admission.

Learned Government Pleader for Services-III takes notice on behalf of the respondents, waives further notice and seeks time to file counter.

Registry is directed not to take out notice to the respondents in view of the above waiver.

Learned counsel for the petitioner submits that the petitioner, *vide* proceedings, dated 06.09.2023, was appointed as Librarian and posted at respondent No.3-Institution, which falls under Zone-I. However, when the petitioner has requested the respondent authorities to permit him to join duty after a medical leave commencing on 12.06.2024, the respondents issued proceedings, dated 05.12.2024 placing him in Zone-VI instead of Zone-I on administrative grounds. The respondents have neither dislocated the petitioner nor issued re-alignment local cadre proceedings under G.O.Ms.No.317, dated 06.12.2021. Nevertheless, the petitioner was placed at Zone-VI. Therefore, learned counsel seeks indulgence of this Court.

Learned Government Pleader for Services-III, on instructions, submits that since there were no vacancies in Zone-I, the petitioner was posted at Zone-VI.

Having regard to the submissions made by learned counsel for the respective parties and in view of the fact that the petitioner was appointed as Librarian in Zone-I, there shall be interim suspension of impugned proceedings in Rc.No.Zones/2785456/2024, dated 05.12.2024 and the respondents are directed to issue fresh posting orders to the petitioner appointing him in Zone-I as per the appointment order dated 06.09.2023.

Post this matter on 12.03.2025 for counter.
