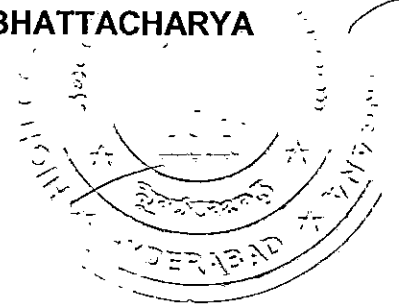

**According to learned counsel, the petitioners filed 4 I.As. before the Trial Court essentially for recalling the scribe/PW.5 who had turned hostile.**

The petitioners' applications were made in the petitioners' Suit for specific performance and cancellation of the Gift Deed executed by the respondent No. 1 in favour of the respondent No.2.

Counsel further submits that the Trial Court dismissed I.A. Nos. 567 and 568 of 2024 on the sole ground of filing I.A.No.569 of 2024 without merits.

Counsel appearing for the respondents/defendant Nos.2 to 5 shall file the counter by 19.03.2025.

List this matter on 21.03.2025.

It is made clear that the Trial Court shall proceed with arguments but not pronounce any order in the Suit.
