WHEREAS the Petitioner above named through his Advocate SRI P VENKAT REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction. more particularly one in the nature of writ of Mandamus declaring the action of the 8th respondent in issuing impugned Notice No.02/2025 dated 03.11.2025 directing the petitioner herein to remove the structures/house bearing GP No.1-86 and land admeasuring 285 Square Yards appurtenant thereto located in Grama Kantam of Kashipur Village, Kandi Mandal, Sangareddy District as being illegal, arbitrary and unconstitutional and. contrary to the provisions of A.P.Panchayath Raj Act, 1994 and Rules made thereunder and set aside the impugned notice dated 03.11.2025 of the 8th respondent and further direct the respondents not to interfere with the petitioners' rights in respect of the property bearing House bearing No.1-86 and land admeasuring 285 Square Yards appurtenant thereto situated at Kashipur Village, Kandi Village, Sangareddy District;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri P VENKAT REDDY, Advocate for the Petitioner and GP for Panchayat Raj and Rural Development for the Respondent Nos.1 to 6 and Sri K. Pradeep Reddy, SC for Gram Panchayat for the Respondent Nos.7 & 8, directed issue of notice to the Respondent No.9 herein to show cause as to why this WRIT PETITION should not be admitted.

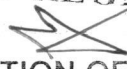
Registry is directed not to take out notice to respondents No.1 to 8 in view of the above waiver.
