COMMON JUDGMENT:

Heard Mr. M.V.Rama Rao, learned Standing Counsel for Telangana State Level Police Recruitment Board, appearing for the appellant and Mr. Munuga Sateesh, learned counsel appearing for respondent No.1 in W.A.Nos.1265 and 1279 of 2025 and respondent Nos.1 to 5 in W.A.No.1336 of 2025.

2. In all these appeals, the appellant is the Telangana State Level Police Recruitment Board (hereinafter referred to as 'the appellant Board'). Under Recruitment Notification bearing Rc.No./41/Rect./Admn.1/2022 dated 25.04.2022 for various posts to the cadre of Stipendiary Cadet Training (SCT) Police Constables (Civil) (Male) notified for Mahabubnagar District, the writ petitioners, who are from Mahabubnagar District, were called for verification of their antecedents, certificates and medical examination/fitness after competing in the recruitment exercise. They were found to suffer from medical conditions



which are amongst those indicated in para E of the Recruitment Notification, which is extracted hereunder:

“E. Medical Standards:

i. Eye Sight: Visual Standards required for the above selection shall be as follows-

Right Eye Left Eye

Distant Vision	6/6	6/6
Near Vision	0/5	0/5
	(Snellen)	(Snellen)

ii. Each eye must have a full field of vision

iii. Colour blindness, squint or any morbid condition of the eye or lids of either eye shall be deemed to be a disqualification

iv. Candidate should possess sound health and be free from any bodily defect or infirmity which will render him/her unfit for the Posts notified

v. Candidates who have the following ailments or defects will not be considered for recruitment to any of the Post notified

➤ Physically Handicapped

➤ Knocking-Knees Pigeon Chest, Flat Foot, Varicose Veins, Hammer Toes, Fractured Limbs, Decayed Teeth, Stammering, Hard of Hearing and Abnormal Psychological Behaviour.

vi. Candidates provisionally selected shall be referred to the District Headquarter Hospital for examination of their Medical Fitness. For any expect option, Candidates shall be referred to Osmania/Gandhi Hospitals, Hyderabad on the basis of the recommendations made by the District Headquarters Hospitals. Candidates who are declared unfit in eye related issues shall be referred to the Sarojini Devi Eye Hospital, Hyderabad based on the recommendation made by the District Headquarters Hospital. The Candidates can be referred/examined only once on such recommendations.

Note: In order to avert getting disappointed at a later stage, Candidates are advised to have themselves examined by a Civil Surgeon before applying for the examination to ensure that they meet the prescribed Physical and Medical Standards.”

3. These writ petitioners suffered from Varicose Veins or Decayed Teeth. It is also undisputed that the District Headquarter Hospitals which assessed the medical fitness of these writ petitioners did not recommend or refer them to



Osmania/Gandhi Hospitals for expert opinion. Writ petitioners claim to have made representations before the Superintendent of Police, Mahabubnagar District raising a grievance about declaration of their medical unfitness, on which by letter dated 19.02.2024, the Superintendent of Police, Mahabubnagar District referred the matter to the Chairman of the appellant Board for taking necessary further steps in the matter. Thereafter, the writ petitioners approached the writ Court as no action was being taken. The writ Court finally passed an interim order earlier directing their re-medical examination done till the disposal of the writ petition. However, the writ petitions were disposed of taking note of the stand of the respective parties and certain decisions rendered in W.A.No.1085 of 2023 *vide* judgment dated 14.02.2024 and W.P.No.18093 of 2020 *vide* order dated 14.07.2023 by directing the writ petitioners to make a fresh representation to the Superintendent of Police, Mahabubnagar for re-medical examination within a period of four weeks. The respondent authorities were directed to consider the same and pass appropriate orders for the re-medical examination of the writ petitioners, however, with details of the hospitals where they are to be re-examined, in accordance with law, within a period of six weeks therefrom.

4. Though it has been pleaded on behalf of the appellant Board that the writ petitioners have not stated anywhere in their affidavit that they did not suffer



from the disease on which they were declared medically unfit nor are the representations annexed or the District Headquarter Hospitals recommend their cases for expert opinion to Osmania/Gandhi Hospitals but the learned writ Court proceeded to pass the impugned direction which though appear to be innocuous but at the end has in a decisive direction also indicated the hospitals where the re-medical examination of the writ petitioners are to be held. As such, the Superintendent of Police, Mahabubnagar District has not been left with any independent discretion to consider their representations, in accordance with law. The appellant Board has no objection to entertaining their applications and passing appropriate orders in accordance with law, but the latter part of the impugned direction may be either set aside or modified to that extent.

5. On the part of the writ petitioners, it is contended that the relevant clause in para E is one sided and does not grant any option for the aggrieved candidate to make a representation for re-medical examination. The representations made by the writ petitioners were duly forwarded by the Superintendent of Police, Mahabubnagar District to the Chairman of the appellant Board, on which they have failed to act upon. The writ petitioners have participated in other physical tests in which there is no remark of their unfitness. However, the grounds on which they have been declared unfit like Decayed Teeth or Varicose Veins are

not proper. Therefore, this Court may decline to interfere in the impugned direction.

6. Upon consideration of rival submissions of the parties, the materials placed on record and on perusal of the impugned order of the learned writ Court, though it appears that the operative part of the order only directs the Superintendent of Police, Mahabubnagar District, to take a decision on the representations of the writ petitioners but at the same time it has also directed the respondent authorities to pass appropriate orders for re-medical examination of the writ petitioners with details of the hospitals where they are to be re-examined. The latter part of the impugned direction, therefore, does not leave any discretion to the respondent administrative authority to take a decision on the matter on the basis of the relevant materials and the conditions of the Recruitment Notification. Therefore, we are inclined to modify the impugned direction to the extent that on representations being made by the writ petitioners as directed by the writ Court, the respondent authorities would take a decision thereupon, in accordance with law, within a period of six weeks therefrom. The latter part of the impugned direction is set aside.

7. The Writ Appeals are, accordingly, disposed of. There shall be no order as to costs.

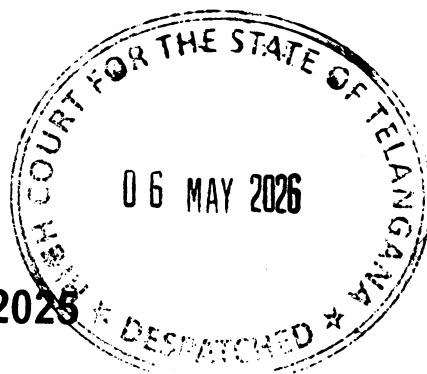
