VEDULA CHITRALEKHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, Order or Orders, Direction or Directions to declare the action of the 2nd respondent in issuing the Integrated Final Seniority in the cadre of Deputy Registrars vide Rc. No.639/2021/SG.I, dt.26.10.2024 in so far as the seniority positions of the petitioners vis-a-vis the respondents 3 to 18 as arbitrary, unreasonable and violative of Article 16 of the Constitution of India and to set aside the same and to issue a consequential direction to the 2nd respondent to properly arrange the seniority position of the petitioners vis-a-vis the respondents 3 to 18 in the cadre of Deputy Registrars afresh by placing the petitioners above the said respondents;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Smt. VEDULA CHITRALEKHA, Advocate for the Petitioners and GP for Services-II, who took notice on behalf of the Respondent Nos.1 & 2, directed issue of notice to the Respondent Nos.3 to 18 herein to show cause as to why this WRIT PETITION should not be admitted.
