No. 265 of 2017 on the file of XXVI Additional Chief Judge, City Civil Court at Hyderabad, pending disposal of SA No. 585 of 2025, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

This application is filed to grant stay of the operation of the decree dated 03.09.2024 passed in A.S. No. 265 of 2017 on the file of learned XXVI Additional Chief Judge, City Civil Court, Hyderabad.

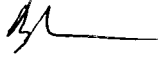
Heard learned counsel for the petitioners (appellants).

In a suit *viz.*, O.S. No. 796 of 2005 for declaration of sale deed document No. 344 of 2004 dated 10.02.2004 as null and void and for consequential delivery of the vacant possession of the suit schedule property, the Trial Court partly decreed the suit partly granting the relief of declaration of sale deed document No.344 of 2004 dated 10.02.2004 as null and void but denied to grant delivery of possession of the suit schedule property. Aggrieved by the same, the appellants (petitioners) preferred A.S. No. 265 of 2017 and the First Appellate Court dismissed the same confirming the relief of declaration of title and also granted relief of delivery of possession of the suit schedule property in favour of the respondent No.1. Aggrieved by the same, the present Second appeal is preferred along with the present Interlocutory Application seeking stay of operation of the decree dated 03.09.2024 passed by the First Appellate Court in A.S. No. 265 of 2017.

The appellants (petitioners) are in occupation of the suit schedule property from the year 2004 onwards till date. Therefore, there shall be interim stay of the operation of the decree dated 03.09.2024 passed in A.S. No. 265 of 2017 on the file of learned XXVI Additional Chief Judge, City Civil Court, Hyderabad, till 06.02.2026.
