Appeal under Section 389(1) CRLP /430 (1) of BNSS praying that in the circumstances stated in the grounds filed in support of the CRIMINAL APPEAL, the High Court may be to grant interim bail to the petitioner/accused No. 2 vide C.T.No.2404 to attend the death ceremony on 15.04.2026 Vide SC No.158 of 2016 on the file of IInd Additional District Judge, Mahabubnagar. At present she is in Central Prison Chenchalguda Women's Cell. vide CT.No. 2404., pending disposal of CRLA No 700 of 2022, on the file of the High Court.

The Court made the following

ORDER

Heard Sri Mettu Goverdhan Reddy, learned counsel for the petitioner/Accused No.2 and Sri Syed Yasar Mamoon, learned Additional Public Prosecutor.

This application is filed seeking interim bail to the petitioner/Accused No.2 on the ground that her brother expired on 04.04.2026 and 12th day ceremony is scheduled on 15.04.2026.

In the light of the same, we have directed learned Additional Public Prosecutor to get specific instructions with regard to the same. He has produced written instructions dated 13.04.2026 of Station House Officer, I-Town Police Station, Mahabubnagar, confirming the said fact.

In the light of the same, we are inclined to grant interim bail to the petitioner/Accused No.2 herein for a period of ten (10) days.

This application is allowed accordingly, granting interim bail to the petitioner/Accused No.2 for a period of ten (10) days i.e., from 13.04.2026 to 22.04.2026. The Superintendent, Central Prison, Chenchalguda Women's Cell, Hyderabad District, is directed to release the petitioner/Accused No.2 today i.e., on 13.04.2026 at 5.00 P.M. She shall report before Superintendent, Central Prison, Chenchalguda Women's Cell, Hyderabad District, on 23.04.2026 by 5.P.M after availing said period. She shall not indulge in any criminal activities during the said period.
