Dt.22/04/2025 on the Plot No.235, in Sy No. 33/2 and 33/3 admeasuring 267 sq yards situated at Chengicherla Village, Medipally Mandal, under Boduppall Municipality, Medchal-Malkajgiri District is illegal, arbitrary and violation of articles 14, 15, 21 and 300-A of constitution of India, consequently direct the Respondent No.5 to receive, register and release the Sale Deed Doc No. P21/2025 of Book-I, Dt.17/04/2025, which was refused through the refusal order No. 05/2025 Dt.22/04/2025 in respect of Plot No.235, in Sy No. 33/2 and 33/3 admeasuring 267 sq yards situated at Chengicherla Village, Medipally Mandal, under Boduppall Municipality, Medchal-Malkajgiri District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI RAPOLU BHASKAR Advocate for the
