Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to vacate the Order dated 18/11/2025 passed in IA No.3 of 2025 in MACMA No.1631 of 2025 by permitting the petitioner to withdraw the deposited amount in the lower in MVOP No.62 of 2022 on the file of Chairman, Motor Vehicles Accidents Claims Tribunal-cum-Principal District Judge at Mahabubabad, in the interest of justice.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 18.11.2025 made in IA No.3 of 2025 and upon hearing the arguments of SRI G RAJKUMAR Advocate for the Petitioner in IA No.3 of 2025 and Respondent No.1 in IA No.1 of 2026 and of SRI AJAY KUMAR MADISETTY Advocate for the Respondent No.1 in IA No.3 of 2025 and petitioner in IA No.1 of 2026, the Court made the following

ORDER

This application is filed by the petitioner/respondent seeking to vacate the interim order passed in I.A.No.3 of 2025 in M.A.C.M.A.No.1631 of 2025, dated 18.11.2025 by permitting the petitioner to withdraw the deposited amount without furnishing any security pending disposal of the above M.A.C.M.A. in the interest of justice.

This Court vide order, dated 18.11.2025, granted stay, subject to condition that the appellant/petitioner shall deposit 50% of the award amount awarded by the Tribunal together with proportionate costs and interest.

Heard learned counsel for the petitioner/respondent.

Learned counsel for the petitioner/respondent prays for withdrawal of the amount already deposited as per the order, dated 18.11.2025, passed in I.A.No.3 of 2025 in M.A.C.M.A.No.1631 of 2025.

On due consideration of the submissions made by the learned counsel for the petitioner/respondent and also considering the reasons cited in the accompanying affidavit, this Court deems it appropriate to modify the order, dated 18.11.2025, and permit the petitioner /respondent to withdraw the amount deposited as per the order, dated 18.11.2025, passed in I.A.No.3 of 2025 in M.A.C.M.A.No.1631 of 2025.

Accordingly, this application is disposed of with the above modification.
