Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction or writ in the nature of Mandamus duly declaring the impugned order vide No. TS/INS-IV/52000707860000699/V/7/2513, dated 11.07.2025, under Section 45-A, of the Employees Sate Insurance Act, 1948, demanding an amount of Rs. 3,14,160/- towards the contribution for the period of 08.02.2019 to 01.05.2020, as illegal, arbitrary and against the principles of natural justice and consequently set aside the same in the interest of justice.

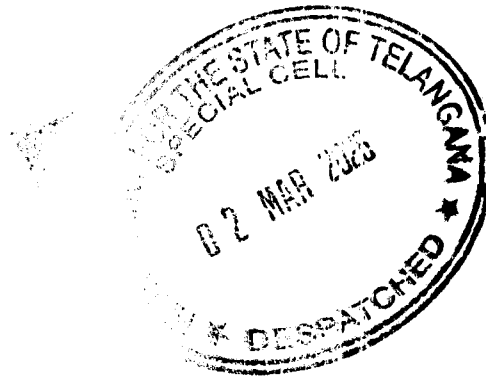
