WHEREAS the Petitioner above named through her Advocate ABHINAV KRISHNA UPPALURI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other appropriate writ declaring the in-action of the Respondents herein, for not taking any steps to fill the existing three vacancies, which has resulted in the denial of the admission to the Petitioner herein in the two year Master of Business Administration, Healthcare and Hospital Management Program for the academic years of 2018-2020 as illegal, arbitrary and in contravention with the fundamental rights of the Petitioner guaranteed under the Constitution of India and consequently direct the Respondent Nos. 3 and 4 herein to grant admission to the Petitioner herein in the two year Master of Business Administration, Healthcare and Hospital Management Program for the academic years of 2018-2020.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of MR.ABHINAV KRISHNA UPPALURI Advocate for the Petitioner, directed issue of notice to the Respondents 3&4 herein to show cause as to why this WRIT PETITION should not be admitted.
