ORDER:

In spite of notice on respondent No.3, there is no representation on its behalf.

In view of the assertion of the learned counsel for the petitioners, there shall be interim direction to respondents 3 and 4 to fill up the three seats under the open category and consider the case of the petitioners for admission and permit the petitioners to pursue the above said course.
