WHEREAS the Petitioner above named through his Advocate M/s. NAYAKAWADI RAMESH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of MANDAMUS to declare the action of the respondents the Proceedings issued in Rc.No.1958/A1/2023/Zone-VI-(Charminar)-LF dated 14.06.2024 wherein promoting the 6th respondent to the post of Station Fire Officer against the Roster Point No.8 under ST Category stating that as adequacy is already achieved in ST Category, though he belongs to BC-B category which is against the rules issued in G.O.Ms.No.2 Social Welfare (SW.ROR1) Department dated 09.04.2004 and G.O.Ms.No.33 Tribal Welfare Department dated 30.09.2022, by ignoring the claim of the petitioner for promotion to the post of Station Fire Officer against the Roster Point No.8 under ST Category, even though he is fully eligible and qualified is illegal arbitrary and unconstitutional and set aside the same with a

consequential direction to the respondents to consider the claim of the petitioner for promotion to the post of "Station Fire Officer" against the Roster Point No.8 under ST Category with all consequential benefits;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s. NAYAKAWADI RAMESH Advocate for the Petitioner, directed issue notice to Respondent No.6 herein to show cause as to why this WRIT PETITION should not be admitted.
