WHEREAS the Petitioner above named through its Advocate S JAGADISH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of writ of mandamus declaring the impugned Proceedings of the 1st respondent bearing No.580/MGU/NLG/2018-19 dated 31.08.2018 in rejecting the reimbursement of the cost of sanitation material to the petitioner's firm as per the bid form and price bid for supply of man power for maintenance of sanitation and house keeping works at Mahatma Gandhi University, Nalgonda as void, illegal, arbitrary and discriminatory and consequently direct the 1st respondent to reimburse the cost of the sanitation material of Rs.38,999/- p.m., as per the bid form and price bid dated 25.05.2017 as well as the work order dated 20.07.2017 issued by the 1st respondent.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri S JAGADISH Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
