Writ Appeal under Clause 15 of the Letters Patent Act, praying that in the circumstances stated in the appeal and the grounds filed therein, praying that the High Court may be pleased to allow the writ appeal by setting aside the order in W.P.No.27787 of 2019 dated 18.11.2025 and resultantly dismiss the wp.

IA NO: 2 OF 2025:

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to grant stay of operation and effect of the order in WP.no. 27787 of 2017, dated 18.11.2025, particularly in so far as it has quashed and set aside the appointments of the petitioners herein (who are now functioning as Deputy Tahsildars from 2019 onwards), pending disposal of the WA.No.1323 of 2025, on the file of the High Court.
