Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of Mandamus and declaring the action of the respondents No.3, 4 and 5 in issuing Shortfall Letter vide Notice No.026029/GHMC/06390/1ABP/C20/2025 dated 22-11-2025 to the Building permit No. 026029/GHMC/06390/IABP/C20/2025 dated 12-11-2025 as being illegal arbitrary and violative of Article 14, 21 and 300-A of Constitution of India and consequently set aside the above the Shortfall Letter vide Notice No. 026029/GHMC/06390/1ABP/C20/2025 dated 22-11-2025 issued by respondents 3, 4 and 5 and to process the Building as observed in order WP No.30229/2025 dated 07-10-2025, and issue work permit order in respect of Plot No.1534, in Survey Nos.78 to 93, admeasuring 300 Sq. yards, situated at Raja

Rajeswara Nagar, Kondapur (V), Serilingampally (M), Under GHMC, Ranga Reddy District, T.S and bounded by North, Plot No.1535 of Smt. K. Jyothi Rani South, Plot No.1533 East, Plot No.1549 West, 40' Wide Road without insisting ULC Clearance Certificate

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to set aside the Shortfall Letter vide Notice No.026029/GHMC/06390/1ABP/C20/2025 dated 22-11-2025 by directing the respondents No.3, 4 and 5 to process the Building permit No.026029 GHMC/06390/1ABP/C20/2025 dated 12-11-2025 and issue work permit order in respect of Plot No.1534, in Survey Nos.78 to 93, admeasuring 300 Sq. yards, situated at Raja Rajeswara Nagar, Kondapur (V), Serilingampally (M), Under GHMC, Ranga Reddy District, T.S., and bounded by North, Plot No.1535 of Smt. K. Jyothi Rani South, Plot No.1533; East, Plot No.1549; West, 40' Wide Road., without insisting ULC Clearance Certificate and pass, Pending disposal of WP 35957 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support and upon hearing the arguments of SMT. THAKUR ROOPA SINGH Advocate for the Petitioner, GP FOR REVENUE Advocate for the Respondent No.1, GP FOR MAUD Advocate for the Respondent No.2, SC for GHMC, G.MADHUSUDHAN REDDY advocate for Respondent Nos.3 to 5 and the Court made the following.

ORDER:

Learned counsel for the petitioner submitted that in similar circumstances order was passed by this Court in W.P. No.16461 of 2023 dated 10.11.2023, W.P. No.19241 of 2025 dated 07.07.2025, W.P. No.20232 of 2025 dated 15.07.2025, W.P. No.23693 of 2025 dated 12.08.2025, and also in W.P. No.30229 of 2025 dated 07.10.2025.

Hence, there shall be interim direction to respondent Nos.3 to 5 to reconsider the building permission of the petitioner in File No.026029/GHMC/06390/IABP/C20/2025 dated 12.11.2025, without insisting upon the production of clearance certificate/No Objection Certificate (NOC) from the ULC authorities in respect of the Plot No.1534 admeasuring 300 square yards in Survey Nos.78 to 93 situated at Raja Rajeshwara Nagar, Kondapur Village, Serilingampally Mandal, Ranga Reddy District, however, subject to other requirements as pointed out in the shortfall letter vide Notice No.026029/GHMC/06390/IABP/C20 /2025 dated 22.11.2025.
