Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus and Declaration thereby declaring the action of respondent No.2 in not completing investigation and not taking action against respondent Nos.3 to 9 and filing Charge sheet in Crime No.226 of 2024 despite registering First Information Report on 19/06/2024 as illegal, arbitrary, violative of Article 21 of the Constitution of India and Consequently direct respondent No.2 to complete investigation and file Charge sheet in Crime No.226 of 2024 by taking action against respondent Nos.3 to 9.

ORDER:

As per written instructions of learned Assistant Government Pleader for Home, several notices under Section 91 Cr.P.C have been served on the petitioner directing him to produce relevant documents regarding his marriage with respondent No.4, but the petitioner did not respond to the notices and is not cooperating with the Investigation Officer. Due to non-cooperation of the petitioner, the investigation is pending.

The petitioner is directed to approach the Investigation Officer in Crime No.226 of 2024 of P.S. Shankarpally and furnish required documents/information, in support of his complaint, within 15 days.
