WHEREAS the Petitioners above named through their M/S CHILLAW ADVOCATES AND LEGAL CONSULTANTS presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to- a) Declare the PESA Gram Sabha proceedings dated 15.10.2025, purportedly conducted for Abbaigudem habitation under Venkatapuram Mandal, Mulugu District, as illegal, arbitrary, without jurisdiction, and in violation of the provisions of the PESA Act, 1996, the Rules framed thereunder, and the proceedings of the Tribal Welfare Department, including RC.No.312/2019/TRI/PESA dated 25.03.2019 and orders dated 24.09.2025, b) Set aside the impugned Gram Sabha Resolution and all consequential actions, including the selection/election of the alleged PESA Committee and any further steps taken by Respondent authorities pursuant thereto, c) Direct the Respondents to conduct a fresh PESA Gram Sabha for Abbaigudem habitation alone, strictly in accordance with the PESA Act, 1996, applicable Rules and Government orders, and only with the participation of the eligible voters of Abbaigudem habitation, at the designated venue within Abbaigudem itself, and d) Direct initiation of appropriate disciplinary action against the officials responsible for the illegal conduct of the Gram Sabha on 15.10.2025.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/S CHILLAW ADVOCATES AND LEGAL CONSULTANTS Advocate for the Petitioners, directed issue of notice to the Respondent No.9 herein to show cause as to why this WRIT PETITION should not be admitted.
