WHEREAS the Petitioner above named through its Advocate M/S SHYAM S AGRAWAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an Order, Direction or Writ and more particularly one in nature of Writ of Mandamus declaring the acts of the respondent No.2 of not allowing the petitioner to operate his current account No.60492454138 with the respondent No.2, freezing the said account of the petitioner without following due process and without notice to the petitioner and not releasing / defreezing the same in spite of repeated requests and more particularly under the letter dated 18/11/2025, as illegal, arbitrary, high handed, violative of several provisions of law and principles of natural justice and judicial precedents and consequently direct the respondents No.2 to defreeze the said account of the petitioner and permit him to operate the account by the petitioner, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/S SHYAM S AGRAWAL Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
