WHEREAS the Petitioner above named through his Advocate SRI S. SRIDHAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the proceedings bearing (i) Lr No. El /MDL/D1/2017-2 dated 24.07.2024 issued by the respondent no. 2 in so far as including the lands in sy.no. 334 of Nizampet Village, Bachupally Mandal, Medchal - Malkajgiri District in prohibitory register and (ii) the Intimation of the Refusal No. 71/2024 dated 19.10.2024 issued by the respondent no. 3 as illegal, arbitrary and contrary to the provisions of Registration Act, 1908 and set aside the same and consequently direct the respondent no. 3 to register and release the gift deed (P 212/2024) dated 18.10.2024 presented by the petitioner in respect of the plot nos. 23 and 24 land admeasuring 1000 Sq.yds, Plot Nos. 25 and 36 land admeasuring 950 Sq.Yards and Plot No.4 land admeasuring 393 Sq.yds, total admeasuring 2343 Sq.yds or equivalent to 1958.98 Sq.mts.in Sy. No. 334 situated at Nizampet Village, Bachupally Mandal, under Nizampet Municipal Corporation, Medchal - Malkajgiri District without reference to Intimation of Refusal No. 71/2024 dated 19.10.2024 and Lr. No. El/MDL/D1/2017-2 dated 24.07.2024.

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of SRI S. SRIDHAR Advocate for the Petitioner, GP FOR STAMPS & REGISTRATION for

respondents directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
