Heard Ms.K.Kiran Mayee, learned counsel appearing for the appellants and Mr.P.S.Rajasekhar, learned Standing Counsel for

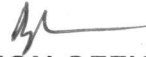
Telangana State Public Service Commission, appearing for respondent No.17.
