WHEREAS the Petitioners above named through their Advocate SRI SIRGAPOOR SAHIL REDDY presented this Petition under Section 528 OF B.N.S.S., praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to call for the records in FIR No. 150 of 2025 registered by Karkhana Police Station dated 16/09/2025 and quash the same in so far as the Petitioner are concerned

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of SRI D.PRAKASH REDDY, learned Senior Counsel representing SRI SIRGAPOOR SAHIL REDDY Advocate for the Petitioners and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 528 OF B.N.S.S., praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings including the arrest of the Petitioners herein in relation to records in FIR No. 150 of 2025 registered by Karkhana Police Station dated 16/09/2025 pending disposal of the above Criminal Petition,

ORDER:

Notice before Admission.

Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2/de-facto complainant through speed post and file proof of service.

Heard Sri D.Prakash Reddy, learned Senior Counsel representing Mr.Srigapoor Sahil Reddy, learned counsel for the petitioners.

Learned Senior Counsel for the petitioners submits that the petitioners have not committed the offences and they were falsely implicated in the present crime. The Police registered the crime solely basing upon the legal opinion dated 06.09.2025, without following the guidelines issued by the Hon'ble Apex Court in *Jacob Mathew v. State of Punjab and another*¹ and in *Lalita Kumari v. Government of Uttar Pradesh and others*².

He further submitted that respondent No.2 issued a legal notice on 03.01.2025, and the petitioners issued a reply notice on 29.01.2025. Thereafter, on 14.03.2025, respondent No.2 issued another legal notice, offering a fair settlement. Subsequently, she lodged the present complaint. Even according to the allegations made in the complaint, the ingredients of Sections 316(2), 318(4), 125 and 49 read with Section 3(5) of the BNS are not attracted.

Taking into consideration the above said submission made by the learned Senior Counsel for the petitioners, this Court is of the considered view that the matter requires detailed examination.

Till then, there shall be stay of all further proceedings against the petitioner/accused Nos.1 to 3 and 5 in FIR No.150 of 2025 on the file of Karkhana Police Station, Hyderabad,.
