pleased to issue a writ or order or direction more particularly in the nature of CERTIORARI (i) Calling for the records lying in the office of the Respondent No. 2 in connection to the dispute No.208 of 2018, dated 29.05.2018 presented by and registered on behalf of the Respondent No.3, as the same appears to have been registered in violation of Rule 55 of the A.P. Chit Fund Rules, 2008 Section 10, 33, 64, 67 and 69 of the Chit funds Act, 1982.

(ii) Quash the Award in Dispute No.208 of 2018, dated 17.03.2023 passed by the Respondent No.4 as the same is vitiated by a defect or jurisdiction, resulted in a use of process of law and violative of Article 14 of the Constitution of India.
