WHEREAS the Petitioner above named through his Advocate Sri Srinivasa Rao Sirikonda presented this Writ Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ of Mandamus or any other appropriate writ to i) declare the impugned demolition order dated 11-09-2023 passed by the 3rd Respondent as illegal, arbitrary, fabricated, and void and to set aside the same, ii) Declare the demolition dated 08-10-2023 as illegal and unconstitutional, iii) Direct the respondents to compensate the petitioner for the loss caused due to illegal demolition. iv) Direct initiation of appropriate action against the officers responsible for the illegal demolition, including the Respondents Nos. 6 to 8 herein and other officers involved, for their mala fide and unauthorized actions, including fabrication of the alleged demolition order, and declare that they are personally liable for their

actions and consequently direct the competent authority to take departmental action and recover compensation or damages from the erring officers in accordance with law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Srinivasa Rao Sirikonda Advocate for the Petitioner, directed issue of notice to the Respondent Nos.6 to 10 herein to show cause as to why this WRIT PETITION should not be admitted.
