Post on 10.02.2026.

The presence of the petitioner Nos.2 and 3/accused Nos.2 and 3 in C.C.No.713 of 2024 on the file of the Junior Civil Judge Court, Vemulawada, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioner Nos.2 and 3/accused Nos.2 and 3 is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law. No such relief is granted insofar as petitioner No.1/accused No.1 is concerned.
