Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the 2nd and 3rd respondents in not taking action on the complaint of the petitioner dated 24/07/2025 to stop the illegal construction as undertaken by the 5th and 6th respondents in Sy. No. 20, admeasuring 1845 Sq. Yards and plot admeasuring 0-20 guntas in Sy. No. 60 situated at Raheemkhanguda village, Bibinagar Mancial. Yadadri Bhongir District though admittedly as per the information furnished by the 2nd respondent, there is no construction permission in favour of the 5th and 6th respondents and though they have been making consincian

by destroying the existing nala in the said land of the zs illegal, unlawful, contrary to law and consequently direct and 2nd and 3rd respondents to stop the illegal construction over the above land in Sy.No.60 and order for demolition whatever the constructio which was made by the 5th and 6th respondents over the above property of the petitioner without obtaining any construction permission

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased To issue interim order directing the 2nd and 3rd respondents to stop the illegal construction as undertaken by the 5th and 6th respondents in the plot admeasuring 1845 Sq. yards in Sy. No. 20 and plot admeasuring 0-20 guntas in Sy. No. 60 at Raheemkhanguda village, Bibinagar mandal, Yadadri Bhongir District without obtaining any construction permissions either from the Grampanchayat or from HMDA, Pending disposal of WP No 38583 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the grounds filed in support thereof and upon hearing the arguments of Sri.M Damodar Reddy Advocate for the Petitioner(s), Sri Pradeep Reddy Katta, Standing Counsel for the Gram Panchayat, for respondent No.2, Gp For Panchayat Raj Rural Dev for the Respondent(s), and the Court made the following.

ORDER

Heard Sri M. Damodar Reddy, learned counsel for the petitioner, and Sri Pradeep Reddy Katta, learned Standing Counsel for the Gram Panchayat, appearing for respondent No.2.

Today, when the matter is taken up for hearing, learned counsel for the petitioner submits that, though the unofficial respondent Nos.5 and 6 have permission to undertake construction, they do not have permission to construct the compound wall.

If that be so, respondent No.2 shall verify the sanctioned plan and, if no permission has been granted for construction of the compound wall, take appropriate action in accordance with law and submit an action taken report by the next date of hearing.
