The presence of the petitioners/accused Nos.2 and 3 in C.C.No.4554 of 2018 on the file of the II Additional Junior Civil Judge-cum-X Additional Metropolitan Magistrate at Kukatpally, Medchal-Malkajgiri District, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
