WHEREAS the Petitioner above named through his Advocate SRI. BAGLEKAR AKASH KUMAR presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to quash the proceedings in C.C. No. 3646 of 2025 on the file III Additional Chief Metropolitan Magistrate Hyderabad, for the alleged offences under Sections 409 and 381 of Indian Penal Code, 1860 and consequently direct the Respondent No.1 to conduct de-novo investigation/ re-investigation in crime No.314 of 2025 on the file of P.S Borabanda, Hyderabad.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. BAGLEKAR AKASH KUMAR Advocate for the Petitioner, and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 06.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

I.A. NO: 1 OF 2025

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to stay all further proceedings in C.C. No. 3646 of 2025 on the file of III Additional Chief Metropolitan Magistrate Hyderabad, for the alleged offences under Sections 409 and 381 of Indian Penal Code, 1860 including the personal appearance of the Petitioner/ Accused No. 1, pending disposal of the present Criminal petition.

The Court made the following:

ORDER

Learned counsel for the petitioner mentioned in Memorandum of Grounds that respondent No.2 is not a necessary party for adjudication of the proceedings, hence, notice in respect of respondent No.2 is required.

According to the Court, respondent No.2 is necessary for adjudication of the proceedings. Hence, notice in respect of respondent No.2 is required.

In view of the same, issue notice before admission.

Learned Addl. Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 through speed post with acknowledgment due and file proof of service.

In view of the urgency expressed by the learned counsel for the petitioner, Registry is directed to post the matter under the caption 'for admission' in adjourned motion list on 06.07.2026.

Learned counsel for the petitioner submitted that the matter before the trial Court is not ripened for trial.

The presence of the petitioner/accused No.1 in C.C.No.3646 of 2025 on the file of the III Additional Chief Metropolitan Magistrate, Hyderabad, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
