Petition under Section 438 of BNSS praying that in the circumstances stated in the grounds filed in support of the criminal petition, the High Court may be pleased to stay all further proceedings in C.C. No. 186 of 2018 before the Honourable Principal Special Court for Trial of Economic Offences - Cum - VIII Additional Metropolitan Sessions Judge, Nampally, pending disposal of CRLRC No. 972 of 2025, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following

order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

This application is filed seeking to grant stay of all further proceedings in C.C.No.186 of 2018 pending on the file of the learned Principal Special Court for Trial of Economic Offences-cum-VIII Additional Metropolitan Sessions Judge, Nampally.

Heard Mr.T.P.S.Harsha, learned counsel for the petitioner and Mr.Pulimamidi Shashidhar Reddy, learned Standing Counsel appearing for respondent No.3.

Learned counsel for the petitioner submits that the trial Court ought to have seen that the complaint was based solely on the Inspection Report, dated 17.04.2018. There is no reference to the Supplementary Inspection Report, dated 27.03.2019 in the complaint, however, the said report was brought on record in the proceedings subsequently. In these circumstances, it is necessary to examine the Supplementary Inspection Report, dated 27.03.2019 in order to determine whether additional charges are required to be framed and whether any additional persons ought to be arrayed as accused.

Learned counsel for the petitioner further submits that the trial Court failed to appreciate that it was well within the rights of the petitioner to file an appropriate application seeking framing of additional charges, and that the trial Court ought to have conducted trial so as to adjudicate upon the said application. He further submits that in the light of the Supplementary Inspection Report, dated 27.03.2019, and the evidence adduced by PWs.2 and 3 subsequently, the trial Court ought to have directed respondent No.3 to file an appropriate application for bringing additional charges on record. Hence, he prayed to grant stay of all further proceedings against the petitioner.

On the other hand, learned Standing Counsel appearing for respondent No.3 opposed for grant of stay.

The submissions made by the learned counsel for the petitioner do require detailed examination.

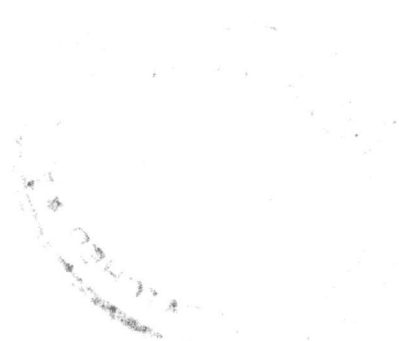
