Chief Metropolitan Magistrate, at :: Nampally, Hyderabad, as against the petitioner/A.1 in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Mr.VINOD KUMAR DESHPANDE, Senior Counsel representing Mrs. DEVINENI RADHA RANI Advocate for the Petitioner and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

IA NO: 2 OF 2025

Petition under Section 528 OF B.N.S.S., praying that in the circumstances stated in the grounds filed in support of the Criminal petition, the High Court may be pleased to stay of all further proceedings including the committal of case in PRC No.234 of 2024 on the file of III Addl. Chief Metropolitan Magistrate, at :: Nampally, Hyderabad against the petitioner/A.1, pending disposal of this criminal petition in the interest of justice.

The Court made the following:

ORDER:

Mr.Vinod Kumar Deshpande, learned Senior Counsel representing Ms.Devineni Radha Rani, learned counsel for the petitioner/accused No.1, submitted that in the very same P.R.C.No.234 of 2024, accused Nos. 2 to 6 have approached this Court and filed Crl.P.Nos.15347 of 2024 and 2102 of 2025 seeking to quash the proceedings. This Court, while ordering notice before admission, granted a stay of all further proceedings, and the said interim order is still subsisting. Therefore, the petitioner is also entitled to the same relief.

Taking into consideration the above submissions, this Court is of the view that detailed examination is required for adjudication of the case.

Notice before admission.

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Post on 16.02.2026 along with Crl.P.Nos.15347 of 2024 and 2102 of 2025.

Till then, there shall be an interim stay of all further proceedings against the petitioner/accused No.1 in P.R.C.No.234 of 2024 on the file of the III Additional Chief Metropolitan Magistrate at Nampally, Hyderabad. In default of filing proof of service, the stay shall stand vacated.

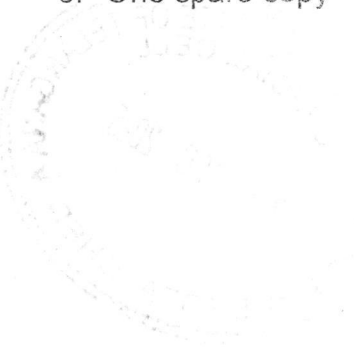
